目前为中国免疫学会临床免疫分会主任委员，中华医学会风湿病学分会名誉主委，国际风湿病联盟（ILAR）和亚太风湿病联盟（APLAR）前主席，《Clinical Rheumatology》和《Int J Rheumatic Diseases》副主编，《中华风湿病学杂志》总编，《中华临床免疫与风湿病》总编，《北京大学学报》（医学版）副主编，《医学参考报（风湿免疫专刊）》主编，《Ann Rheum Dis》和《Nat Rev Rheum》等杂志编委。

长期从事风湿免疫病临床工作，主要研究方向为类风湿关节炎、系统性红斑狼疮、干燥综合征等自身免疫病的发病机制及免疫治疗。发表论文近 600 篇，其中 SCI 论文 200 余篇，包括在《Nature Medicine》、《Immunity》、《Nat Genet》、《Cell Host Microbe》、《Ann Rheum Dis》、《Nat Rev Rheum》等杂志（IF 8.96-31.62）发表论文 30 余篇。主编（译）和参编了《类风湿关节炎》、《风湿免疫学高级教程》、《凯利风湿病学》等风湿病学专著 30 余部。
